

INT./EXT.- KANE'S HOME- DAY

Kane and his wife are talking about how delighted they are to be in a new place as they are unloading boxes in their new Chicago home, where Kane wife went to college but moved after graduated in Law. She asks Kane whether he misses the field force, despite the fact that he is happy to be at home with his wife and son, Kane Jr. He says he thinks about it. When Kane turns on the news on TV, he sees a tragic event between the police and a notorious gang that happened more than ten years ago and took the life of a 12-year-old kid. The police officers who were involved in an incident were acquitted of all charges. Trey Combs, a well-known gang leader, was charged with the murder. Kane and his wife are disappointed that the police were not found to be responsible for the killing.

Son of Kane was outdoors playing with a toy pistol while wearing headphones. After hearing sirens, Kane rushed outside with his Glock, only to witness a couple police officers ready to shoot his kid. Kane opened fire, killing one of the officers, while the other officer threw his pistol on the ground. After being surprised by the sight of the officer's dead body, Kane puts the gun to the side and kneels down, placing his hands behind his back.

Five police officers approach and point a gun at him. They firmly apprehend him. Kane was scheduled for trial. He was beaten and interrogated by the officers for the death of their fallen comrade. Kane asks for his lawyer, one of his closest friends. His lawyer informs Kane that things don't appear promising for him. Kane explained the entire incident to him. The lawyer warned Kane that he would have to endure the dangerous American jail system and that the guards would kill him at the first opportunity.

INT. CHICAGO SUPREME COURT- DAY

When Kane appears in court, his lawyer describes to the judge what transpired, describing how the officers targeted an unidentified suspect and intended to kill Kane's son in clear daylight. Any responsible parent would have responded in the same way. Testifying against Kane, the officer who witnessed his comrade killed stated that they weren't going to shoot the child. Kane becomes furious and accuses him of lying. The judge pointed out that Kane should have understood how to manage the matter and acknowledged his appreciation for his resume. Despite his outstanding resume and all of his achievements for the United States of America, the judge must hold him responsible for all his actions. After the court gives its decision, Kane is sentenced to life in prison with

no parole.

INT. KANE'S HOME- DAY

As the police slowly pass the home, Kane's wife and her son are sitting on the porch. She wants to call the police, but she can't. When Kane calls her, she describes how the police officers are sending threats while driving past their homes every day. Kane's tells her to go to her mother's house temporary until things cool down.

INT. CHICAGO PRISON- DAY

Kane is taken to his cell, and meets his cellmate. His cellmates remembers him and tell him he heard about what happened and that it was all on the news. His cellmate tells him that a notorious gang lord will try to recruit him. He tells him his name is Trouble and he is in charge of this whole facility including the prison guards. He tells Kane if he's going to survive this place he will need him on his side for protection. Kane says he doesn't need anyone for protection and that he can protect him self. His cellmate tells him pride will get you killed in here.

KANE

(Kane and his cellmate is in the lunch line getting their food)
Well, pride to protect my son got me here so it'll keep me safe here, I'm in here for life so I have nothing to live for except knowing that my son is going to grow up without a father. So figuring out to protect him and my wife from inside is my only job.

CELLMATE

Well I hope the best for you. That's Trouble over there, try staying out his way. He's in here for....

KANE

I know already why that scumbag is in here, you don't have to share anything to me. It was all on the news. He's been in here over a decade.

(Kane and his cellmate walks to an empty table and sit down and eat)

One of Trouble's soldiers walks up to Kane and tells him that Trouble wants to talk with him

KANE

If he wants to talk to me, tell his lazy ass to come over here and talk to me, if not get the hell out of my face.

SOLDIER

Who you think you are? Just because your an ex cop, you get the same treatment like everyone in here. If Trouble summoned you, you come immediately or else I'm going to beat your ass!

KANE

Is that a threat?

CELLMATE

(Scared)

Come on Kane, lets go talk to Trouble, I'll go with you

SOLDIER

You better listen to your Celly, He's smart and already know what will happen if you don't come

KANE

Your still here?

Trouble soldier throws a punch at Kane and Kane grabs his hand and crushes his hand breaking it, Then knocking him out.

KANE

(looking at Trouble)

Big bad wolf come get your mans up!
He's taking a nap and need some assistance!

10 of Trouble soldiers gets up ready to fight but Trouble tells them to sit and continue to eat his food not worrying and ignoring Kane. Kane get's up from eating and walks over knocked out soldier and walks to his cell.

CELLMATE

Man, Kane you just put a target on your back. You need to stay alive for your son and making enemies in here will make that impossible. Trouble doesn't have to do anything to you because the Guards will. I know your a

bad mutha fucker but you can't fight both the gang and guards by yourself. If Trouble get's any idea of me being on your side then I am dead.

KANE

I can handle myself, thanks for the tip. Remember I have fought for this country and I've seen things that I will never tell but one thing I can say is that I have skills that no one has achieve in this lifetime plus I have people in high places that will make sure that I'm ok. I didn't think Trouble roll like that, he does have a lot of soldiers. hahaha

KANE

I have my lawyer investigating the officers motives and hopefully he finds something that can get me out of here.

CELLMATE

I'm not trying to be negative, but your not getting out of here. You murdered a cop.

KANE

It was either my son or the cops, They were going to kill my son if I'd didn't respond, I shot the cop before they shoot my son. They suspected my son robbed a liquor because the suspect had a red shirt on and my son happen to have a red shirt that day, playing with his toy gun wearing headphones unaware of what was about to happened. What would have you done?

CELLMATE

Well now after hearing what happened, I would have done the same. Man I'm sorry it had to come to this.

CUT TO:

INT. KANE'S WIFE MOTHER HOUSE- DAY

(Phone Call between Kane's Wife and him. His wife is emotional)

(because her son is asking where
is dad at?)

KANE

Kane tells his wife she has to be
strong for Kane Jr.. He tells her he
can't have any visits for next 5
years.

KANES WIFE

(Emotional weeping while talking
on phone with Kane)

Kane I can't do this without you! How
am I going to raise Kane Jr. up to be
a man.

KANE

I'm going to have my brother help out,
My lawyer is investigating everything
so I need you to be in high spirit
babe. I love you, I have to deal with
this notorious gang lord Trouble
everyday so I have to keep my mind
strong and by you being strong helps
me.

KANES WIFE

Trouble? Isn't that the guy that
murdered that young boy in that
shooting we seen on the news?

KANE

Yep, that's him and he runs everything
in here including the cops. I need you
to do me a favor asap, I need you to
get Private McCarthy number for me,
he's hard to find he's like an ghost
because the guards are going to try to
kill me in this place and only Private
McCarthy can get them off my back.
They haven't try anything yet because
this is so tragic is so fresh but I
know when things cool down they will.
(Prison phone says phone will end
in 10 seconds)
Well I love you, kiss little Kane for
me and Talk to you later.

KANES WIFE

Love you too and I will

CUT TO:

INT. PRISON- DAY

Kane is watching news on the television and it is talking about the 8th homicide within weeks apart and reporters suggestion its a serial killer on the loose. Trouble walks up to Kane and sit next to him.

TROUBLE

Now Kane, I know who you are and only reason your still alive is because I've allowed you to. I can have this whole prison jump on you and you'll be dead in a heartbeat or the guards either way you'll die at my order. You can live and no one would bother you if you do one thing.

KANE

What's that Child killer?

TROUBLE

So you've done your homework I see. Then you know that I am nothing to play with. First of all I didn't killed no innocent child, I'm ruthless but that ain't my style. The child was caught in the middle of a crossfire and ended up getting hit. There where no bullet shell found, The cops tampered with the evidence and made it disappear so it was easy to put that murder on me. But anyways I need someone with a clean record on the outside that is legit to smuggle some drugs in here so I can run an empire. I need your wife. I'll give you 30% of everything. If you reject this offer, My protection will be no more and I won't hold the cops back. You will have to fight, I know your capable of it because your a retired special op, undercover narcotic agent and military soldier. But you and I both know that will not last forever, your just a number in here.

KANE

(Serious Demeanor)

Well, thank you for your long proposition, but I reject. I kind of believe you about that child getting

killed but you still was in the middle
so I have no sympathy for you.

Also I wish any of you will try me. I
will bring excruciating pain to anyone
who stands in my way! Tell the
prisoners and guards Kane is about to
bring the Hurricane!

like I said I reject!

Trouble turns around and snaps his fingers to tell his soldiers to rush Kane. Until the guards start firing smoke bombs, start beating Kane, and then throw him in the hole, Kane fights at least eight Trouble soldiers, tearing them apart and breaking legs and arms. Later that night, five guards chained up Kane and started beating him until he was completely exhausted. They left him hanging there for four days before freeing him and feeding him.

As Kane watches the news while in pain, the serial killer keeps killing. While Kane notices, that gang members are being killed, the majority of the fatalities in Chicago and the surrounding areas are police officers. Trouble talking to his gang and ordering them to find out who is murdering his members, Trouble is enraged. He orders them to declare war on any involved opps. Trouble was overheard by Kane, who then called his wife to ask her to keep their son off the streets because a war was coming. After the prison doors are locked, Kane reads in his cell before going to sleep. The guards awaken Kane while he is sleeping, quietly open his cell, and grabs him.

They told him that if it wasn't for Trouble telling them to not kill him, they would have killed him a long time ago for killing their fallen comrade. Kane agrees only to get the guards off his back until he can get in contact with Private McCarthy. Kane then calls his wife the next morning and tells her everything and she is freaking out but is okay with it if it keeps Kane alive and safe.

CUT TO: 2 YEARS LATER

INT. PRISON- DAY

Kane is on the phone with Private McCarthy, outlining the circumstances surrounding his situation. He requested that he relocate his family to a secure area and order the security personnel to leave him alone. McCarthy advises Kane that, while it is possible, there is no guarantee that he will be able to have his sentence reduced. Kane is telling him to do

whatever it takes to make that happen. He tells the story of how he once saved his life and made a vow to always owe him. McCarthy promises to visit Kane the following week, along with some senior members of the American military's secret services and chief of police.

CUT TO:

INT. POLICE OFFICER- HOME

Michael in all black sneaks in officer home and kills the wife and daughter while officer is getting out the shower.

When the officer is dressed, he calls his family but gets no response. He runs to his bedside to get his gun out of fear and slowly goes down the stairs while calling for his wife and daughter. When entering the kitchen, the officer notices blood all over and a man with glasses holding a gun with a silencer attached sitting on the cabinet next to him. Because his wife and daughter are no longer alive, the man tells him to stop worrying about them. The officer shoots his gun, but there are no bullets in it, after becoming enraged and weeping. He is warned to sit down, or the killer will shoot him. He drags the officer into the living room, where his wife and daughter had their throats cut, while tying him to a chair. He is screaming while having tape over his mouth when the killer shoots him in the head. The murderer begins grinning, takes out a pen and paper, writes "dvojče" on it, places it on the kitchen cabinet, and then uses the bloody knife to attach the note to the kitchen cabinet.

CUT TO:

EXT./ INT. OFFICER HOME- NIGHT

The CSI searches the entire property for evidence as the police encircle the crime scene. The note that was stabbed into the cabinet is visible when the chief grabs the evidence and reads it out loud. He exits the building and picks up his phone.

(Chief of Police is on the phone
with McCarthy)

CHIEF OF POLICE

McCarthy, another officer murdered along with his wife and daughter. No fingerprints, footprints or anything found. This killer is a ghost and never makes a mistakes. He left a note

that says dvojče. It makes no sense. I don't understand the what it means. I think we need to go with Operation K. Much as I want that bastard to rot in prison. He might be our only chance in finding this Killer. The board doesn't want to do this but they also don't want any more cops murdered. Tonight was the 10th cop murder in last 2 years and the number is going up and its link to this one.

MCCARTHY

Okay, Chief we can all sit down and discuss the situation, I mention it to him but he need the agreement in writing and your signature on it.

CHIEF OF POLICE

Okay, sounds good. I hope we are doing the right thing. Putting another cop killer on the streets to capture another.

MCCARTHY

first of all lets not assume that this killer is targeting cops, other civilians are being murder as well as gang members. so lets not jump into any conclusions.

CHIEF OF POLICE

Yeah your right

MCCARTHY

Chief have you ever ask about what happened that night Kane shot your brother?

CHIEF OF POLICE

No, I haven't I wouldn't know what I would of done. The only reason why I haven't done anything because I caught my brother doing *Heroin weeks before but didn't know if he had a problem so I turned the blind eye.*

MCCARTHY

What are you serious!? Why didn't you report it! That would have been evidence against him and Kane would

have been freed.

CHIEF OF POLICE

I couldn't snitch on my brother, plus it was weeks ago and he was off duty. When my brother died I couldn't live with myself knowing he had a problem, that same day I try telling him to get some help but he cussed me out and stormed out with his partner then I got the called. His death I blame myself for, but now I need Kane to capture this Killer before he comes after us..

MCCARTHY

(Confused of Chiefs statement about saying before he comes after us)

What? Why would he come after us?

CHIEF OF POLICE

(Nervous)

Well cops are dying and we can be a target that's what I mean.

MCCARTHY

Well tomorrow morning, we will wit down with Kane and discuss the deal.

CHIEF OF POLICE

Make sure he has no contact with his wife or son when he gets out, he has to be undercover.

MCCARTHY

K. Deal

CUT TO:

INT. CHIEF OF POLICE OFFICE- DAY

Kane is brought in by the officers, chained from his feet to his hands. Kane requests that the handcuffs be removed. Have them removed, the chief commands. They explain why they brought him in and how, if he is successful in capturing the serial killer, he will only be sentenced to five years in prison and five years of probation.

KANE

What if I can't catch this man, does that mean the deal's off.

CHIEF OF POLICE

Yes, that means you will rot in prison for the rest of your life! and can't watch your son grow up.

KANE

Don't bring up my son ever again.

You think I'm a fool and dumb huh?

looking at the pictures all around your office, You are related to the officer I killed aren't you?

CHIEF OF POLICE

Yes that was my brother and trust me I don't want you to see the daylight ever again but my brother had some skeletons in his closet that makes this deal a little easier to do. Those skeletons are buried in the past now it's time to capture this killer. Only thing that we have that is evidence is this note that was stabbed to the cabinet with the bloody knife he used to kill the officer, wife and child.

KANE

Let me see the note? dvojče

CHIEF OF POLICE

Do you know what that means?

KANE

It means Twin. Central Europe

CHIEF OF POLICE

How did you know that?

MCCARTHY

Kane and I was station in Europe for 4 years, He learned the language because he had to live with the people of a village to be able to capture Yahman Human, a *Terrorist*.

CHIEF OF POLICE

You are the one who captured Yahman Human? wow he killed over 438 people and you taken him out.

MCCARTHY

Yes, he did and also saved my life from a sniper that in seconds was going to shoot me from the roof tops but i heard a sniper shot and it was Kane on the opposite side of the building of the sniper and killed him saving my life. I owe him my life.

CHIEF OF POLICE

That's very brave of you

KANE

No it wasn't bravery, it was my duty to serve and to protect my country and other country that can't protect themselves.

KANE

Chief, I'm truly sorry for your loss, I really wouldn't have done it if i have any other choice.

CHIEF OF POLICE

Yeah i know, i know.

KANE

Okay, can you get some files for me, the names of all those who where murdered in 2 years, gang memebbers and cops.

MCCARTHY

Why just those?

KANE

Well there is a pattern that the killers is following. I gather this information by watching the news.

CHIEF OF POLICE

Okay you got it you'll have it delivered at your home first thing in the morning. Kane you won't be released till morning so just hold out one more night.

KANE

I'm fine with that

They take Kane back to his cell and on the way to his cell, Trouble stops the officers and tell him if he can have a word with Kane. Trouble start telling Kane that he knows the true story behind Chief brother killings and told him he would have done the same. Trouble tells Kane that he heard about the deal he made with the U.S.

KANE

(Curious)

How do you know? who told you? That was supposed to be in secret.

TROUBLE

Well just say I got my ways, all I want you to do is find this bastard and kill his ass. He's taking out almost 12 of my soldiers. He's the only one that could do something like this.

KANE

Well, I'm not 100% sure what's going on and don't know who all is involved. I can't assume without evidence.

TROUBLE

Well just know that My members that are dying are getting murdered at their homes and along with their families. I mean babies, mothers and children's. If its the same killer, he's a sick mutha fucker.

KANE

Ima do my best.

TROUBLE

Oh, they found a bullet of mine from that incident that had hit the child in the leg. The child's chest was pierced by a Glock 19, and all of my guys have 9 millimeters. Glock 19 is used by the cops. Just to let you know:

KANE

I'm curious now.

TROUBLE
curious about what?

KANE
Nothing. Okay gotta go
(Trouble and Kane shake it up and
head to their cell)

CUT TO:

INT. CABIN IN THE WOODS- DAY

Kane is looking into the victims' names. He's reviewing on the laptop but is frustrated that he can't connect the names to anything. He has nothing but a collection of recently deceased police officers and gang members. He is growing weary, and he make some coffee in the kitchen. Kane's wife is delighted to hear his voice when he calls her. He explains to her everything that is happening, the agreement he made, and why he's unable to see them until the work is finished. She is excited. She sends him a photo of her son, who is now almost a teen. She warns Kane to take extreme caution. He tells her not to return calls from this number. He disconnects.

CUT TO:

EXT./INT DECEASED OFFICER HOME- MORNING

Kane approaches the crime scene through the gap in the caution tape. Without Kane's knowledge, Michael, the murderer, is photographing him across the street before walking away. Kane enters the house on foot. He examines the scene of the crime. looking at everything that appears to be out of place. He enters the living room and scans the couch. He discovers a strand of blonde hair and believes it came from the wife or daughter. He notices from their photos that the mother and wife both have brown hair. So he puts the hair in a bag. He then calls McCarthy to meet him at the victims house. McCarthy pulls up and Kane hands him the strand of hair to get tests from it. He also tells him by looking at the pictures. He noticed that every victim have kids. He tells McCarthy, this could possibly be a personal revenge.

KANE

Someone is intentionally choosing out these police officers and gang members, McCarthy. This killer seems like he won't stop until all of his victims are gone and dead. We're hoping that hair can identify this person. I'm going to rest up now so I can start over tomorrow.

MCCARTHY

Okay sounds good Kane, if anyone can solve this crime it's you.

KANE

Oh, and if you look at the photos, you can see that each murder is carried out without creating a significant mess, which indicates that the killer acts alone.

MCCARTHY

Very interesting, crazy how you can figure that out by looking at a picture, you always was ten steps ahead of everyone.

KANE

It was just dedication to be the best, I put my all in this.

CUT TO:

INT./ CABIN- NIGHT

Kane is once again investigating the victims' identities at the cabin. While doing research, Trey Combs, Trouble by Name in the Streets, read an article about him being arrested on the day a small child passes away due to gun violence. Kane murmurs to himself, "How is that shooting related to anything right now? I thought it was too long ago." A lengthy list appears after he brings up all the identities of those engaged in the shooting. Kane started to nod off on the couch before he read the names. Michael slips into the cabin unnoticed as he falls asleep, places a bloodied knife next to him, and writes "call at 8 p.m." on a piece of paper with "dvojče" and a number next to it.

CUT TO:

INT. CABIN- EARLY MORNING

When Kane awakens from his slumber, he immediately makes his way to the bathroom to take a shower and get dressed. When he returns down the stairs, he notices the message and the knife next to the couch on the coffee table. He takes out his revolver and scans the area to make sure no one is around. When he gets to the police station, he reads the message and

puts the bloodied knife in the bag. The same night, a police officer was killed by having his throat cut along with his two sons and daughter. It was a horrific scene. Kane is instructed by McCarthy to meet him at the crime scene. When Kane arrives, the police detain him at the chief's command. The chief informs Kane that the murder weapon in this case was the knife he brought back to the police station.

That knife cut the necks of all five victims. Kane is upset and sure that it wasn't him. He claims that someone broke into his cabin and left the knife there along with a message he left. McCarthy advises Kane to keep calm and let the police to use his phone's location to show it wasn't you. Kane is being accused with either being the murderer or conspiring with the murderer, by Chief.

He is placed in the police vehicle, and they head to the police station. The location proves that Kane was at the cabin the time of the murder.

After being released from his handcuffs, Kane gets in his car to go home when all of a sudden he receives a call from an unknown number. He responds. The voice on the other end is male.

CUT TO:

INT. KANES VEHICLE- NIGHT

(Kane is on phone with Killer)

MICHAEL KILLER

Hey, Kane how's it going?

KANE

Who is this?

MICHAEL KILLER

(Speaks in Czech)

This is dvojče.

So I am going to make this quick.

My name means the world to me. The value is priceless. I want you to deliver a message for me, and if you don't i will kill your beautiful wife and your bright son.

KANE

You bastard if you touch my family I will kill you!

MICHAEL KILLER

Relax Kane, I know you will, I believe you, Your a cop killer just like me. Oh yeah I have a message to Trey Combs. Tell him, killing gang is only for fun hahaha. They really not my target, Let Trouble, that's his street name right? let him know he's not safe in prison surrounded by his thugs. hahaha I will come for him when I'm ready.

KANE

What do you want from me?

MICHAEL KILLER

I chose you, I sent a kid to rob the liquor store wearing a red shirt, and I radioed The closest officers to your house, knowing that one of them was hooked to heroin so Knew he was going to shoot. The cherry on top was that i gave your son a toy gun. hahahahah

KANE

(Furious)

You did what!? That's how he got that gun, me and my wife couldn't figure out how he gotten that toy gun.

So you planned all this out, So what's your purpose in all of this.

MICHAEL KILLER

My end game is to complete my hitlist before before November 27.

KANE

That's 1 week from today

MICHAEL KILLER

Ding Ding! You are right Kane, Now before i hang up, please pay attention to the details I am going to tell you, matter of fact get a pen and a paper and write them down. Okay I have it, tell me.

MICHAEL KILLER

(Angry)

You're really going to lie to me,
Kane. I'm looking at you right now.
Now stop the car and fetch a pen and
paper! Please don't aggravate me!

Put Chief's name on the paper and say
I'm saving him last because he's a
good guy, and I'm not talking about
Chucky. Tell him he has a beautiful
family that I will be visiting soon.

Sorry for the humor I crack myself up.

KANE

What does Chief have to do with any of
this?

MICHAEL KILLER

More than you know Kane. More than you
know.

I'm late for my next appointment, Now
last step is to not get anyone
involved or else you wife and son is
dead.

KANE

(Angry and Afraid)

What you mean? your lying, my family
is hidden!

MICHAEL KILLER

As soon as your brother's voicemail
plays, you'll understand that I'm not
joking around and that I'm serious.
Hang up, and I'll call you right back.

KANE

(Calling his brother on phone and
voicemail then he gets phone call
from unknown number)

MICHAEL KILLER

Well looks like your brother is going
to make the family reunion hahahah

KANE

Your going to die you peace of..

(Phone Hangs up.)

CUT TO:

INT. PRISON- DAY

Kane and Trouble is sitting in the interrogation room and Trouble is wondering what's going on. Kane hands him paper and he reads it.

TROUBLE

What is this?

KANE

Note the killer told me to write and give to you.

TROUBLE

(Furious)

How the fuck, do he knows who I am? So killing members from my gang is a game to him? I bet its one of my enemies doing this, I'm going to get the whole hood to start a war!

KANE

Trey Shut up! It's not your enemies doing this, trust me this man is intelligent, he has a hitlist of people he's going to kill.

He's a Covert Narcissist! He has

The propensity to break peoples' boundaries. What ever happened to this man, he made it personal and he's filled with vengeance. Something has triggered a monster that can't be tamed. We are dealing with the DEVIL!

TROUBLE

Then what are we going to do?

Can you go to this address and tell my whole hood Trouble said the Blizzard is coming and they will know exactly what that means?

KANE

Yeah I'll do that, Oh yeah one other thing he said that i don't understand. He said that he had to complete his hitlist by the 27th of November. That's exactly a week from yesterday.

TROUBLE

Yeah that date don't ring a bell.

OH MY GOSH! I'LL NEVER FORGET THAT DAY

That young child passed away on that very day. He was at a birthday party across the street with his little buddy or cousin when the shooting took place. But what does that have to do with anything? That whole shooting was on social media. Gang lord vs. police officers lead to child being shot and killed and the video will pop up.

KANE

I don't think anything but I'll get the news clip and video.

TROUBLE

Just be prepared to watch. Its a sad site

KANE

Yeah I think I'll be alright. I gotta go.

CUT TO:

EXT./ HIS BROTHER HOUSE- NIGHT

Kane knocks loudly on the door. When he enters the house and there is no response, he finds his brother bleeding on the floor and still breathing. Kane dials 911.

CUT TO:

INT. HOSPITAL- NIGHT

Kane brother room is surrounded by cops. Kane is weeping sitting on his brother side. His brother wakes up but barely speaking. Kane ask him did he see who did this? KANE

He told me to tell you the blizzard is coming.

OG

Is that what he said?

KANE

Yep

OG

Thanks Young Blood, get the troops and keep an eye on his daughter at all times.

CUT TO:

INT. HOSPITAL- NIGHT

Only three of the victims who were shot are still alive when Kane looks at all the victims, along with their families. His eyes opened wide, and his wife's name, Kristine Humphry, suddenly appeared. However, Kane was curious about how this case related to her, so he Googled her name and discovered that she was the police officer's lawyer. Prior to the trial, all evidence disappeared; Trey Combs' pistol was found, so they decided to blame him for the entire incident, even though there wasn't enough evidence to indict the police officers other than gun shells that were reported at the scene of the crime.

KANE

That's why I'm involved, he's taking revenge on my wife by bringing my family into this. Damn Bastard.

Kane looks up the video of the shooting of the 12 year old kid. He watches it and then pauses it, He see's the kid that gets shot and dies, and anther kid trying to pick him up while crying and weeping. Kane zooms in and pauses the video trying to get a good look at the kid before he gets shot. Now he pauses and zooms in when the two kids are side by side. He notices something.

KANE

(Shocked and Blown away by what he see's)

What the hell? Their twins.

(Czech language)

dvojče! He names himself Twin because they killed his brother! He was a twin. He's filled with hatred.

CUT TO:

INT. HOSPITAL- NIGHT

Michael sneaks in a room where they keep, medical equipment and see's a man sanitizing the equipment so he sneaks up behind him and stabs him to death and puts on the scrubs and I.D.

CUT TO:

INT. HOSPITAL- NIGHT

When Kane arrives at the hospital and goes to his brother's room, he finds him lying on the floor, unable to breathe, so he calls for help, and the nurse arrives. Kane then rushes outside and pursues the man he saw running. He is closing in on him, but he starts shooting at him with his gun when Kane shelters behind vehicles and Michael runs out of ammunition. Kane grabs him, punches him, and they are fighting. But Kane recognizes that this individual possesses abilities beyond anything he has ever seen. Kane managed to stab Michael leaving him leaking from his side. Michael, By using the pistol's grip to knock Kane unconscious, Michael is ultimately able to escape.

CUT TO:

INT. MICHAEL HOME- NIGHT

Michael enters his home and immediately runs to the bathroom to stop the bleeding by stitching himself up. Then, after changing, he enters a hidden room that was created beneath his house.

possessing four advanced military computers, all of which contain information on his plans over the course of five years. He is aware of each victim's name and the size of their family. He unlocks a door to reveal Kristine and her son chained within. While having her lips taped, she is

screaming. Michael then pulls the tape off. She starts to converse with Michael, but he slaps her and puts the tape back on her mouth. Michael describes her husband as a tough and brilliant man who is actually solving this case, but he won't live long because I'll kill him when I'm ready.

MICHAEL KILLER
(Angry and Weeping in Hatred)

Let me now explain to Kristine why your here. My twin brother Samuel Hart and I had a blast on November 27th, 14 years ago as we celebrated our birthday. You see, we were always together. Since we did everything together

Our parents distanced us from one another after their divorce, and Samuel and my father were visiting us and celebrating our birthday together. On that very day, Samuel passed away. It was both the best and saddest day of my life when he died. Trouble and his gang decided to have a shootout with the police with gunfire that day. Samuel was struck in the leg by one bullet, while the other passed through his heart. The gunshot that murdered my twin brother was a police bullet. My entire life is what I am holding in my hands. This is the bullet that went through my brother's heart. This leads me to you because I sat in court for two years straight to see my killers get away with murdering my brother while they locked up the man who didn't do it. Kane is ignorant, huh? To ensure your safety, your father kept you a secret. He wouldn't ever consider that a 26-year-old guy could do such acts. Well, when you take everything away from a man, he'll do whatever it takes to make it right, but in this case, it'll never be right. I have to live with this pain for the rest of my life. Chief of Police, you father. That's your secret, and here's mine: all I know is what I learned from my father. Kane only has faith in my father. Pvt. McCarthy, You see, due to the

lifestyle he led while serving in the secret service, my dad gave us our mother's last name rather than his. But everything nice has to come to an end. Good conversation. Oh, don't worry, I'll keep your son alive so he gets to feel what it's like to live without his parents. I had to go visit a ruthless criminal in prison.

CUT TO:

INT. PRISON- NIGHT

Michael storms the jail, killing every guard. He opens up.

the entrance of the jail, where all of the inmates are. He kills each of them one by one until only Trouble is left.

Trouble ask who the man is. Michael tells him.

MICHAEL KILLER

November 27th. 14 years from this very day. My twin brother was murdered because of a shootout between you gang and the policeman. You see, we where enjoying our birthday together after not seeing each other in a long time.

TROUBLE

I didn't kill you brother, I'm sorry that happened to him. That shootout wasn't even my fault. The police officers was looking for an armed man and my gang happen to be in the area and it popped off but we never meant for your brother to get kilt. So what are you going to do? Shoot me?

MICHAEL KILLER

No matter of fact I'm going to kill your with my bear hands. I'll toss the gun over there and if you can get to it then you can shoot me.

TROUBLE

I'm going to beat your ass for killing my homies. No turning back now.

Michael wriggles free as Trouble comes in, grabs him, and punches him as he is thrown onto the table. Michael is having trouble defeating him, which gives the impression that he will win easily. Then, Michael wipes his lips clean of the blood. He starts to punch and kick really hard. Michael punches Trouble with unreal power, knocking him off his feet. Michael falls to the floor behind him, wraps his body over him, and breaks his neck. Michael departs.

(Whispers)

Don't worry I'll let your daughter
live, your bullet didn't kill my
brother.

CUT TO:

INT: PRVT MCCARTHY HOUSE- NIGHT

MCCARTHY

Sitting on his couch drinking a glass
of whiskey, then gets a phone call
from Michael

(On the phone on speaker, with
Michael while Kane standing in
the shadows listening to their
phone call)

So is it done son?

MICHAEL KILLER

Yes, pops its it done.

MCCARTHY

did you get rid of Chief?

MICHAEL KILLER

He won't get far, he calls himself
trying to leave town but not knowing i
put a bomb in his car and once he gets
out the car kaboom! No more chief.

MCCARTHY

What about Kane, did you finish him
off yet? You can't paly around with
him son, he's knows eveything I've
taught him. You have to get rid of him
and his family. Does Kane know that
Chief is his wife father?

MICHAEL KILLER

No, I don't believe he does, but he will discover it since he

is solving a case that was intended for him. Hahaha, I'm going to burn his wife and boy alive or let him live who knows. . Kristine will perish in the flames. I haven't been able to figure out how she has managed to bear the guilt of letting my brother's killers go free all these years.

MCCARTHY

Kane saved my life, so I can honestly say that it was difficult to just let it go. However, since he married the woman who was the reason my son's murder charges were dropped, it was simple to plan all of this out without regret. Son, it will all be finished shortly. Did you put an end to Trey?

MICHAEL KILLER

Yes, I gave him a hand-to-hand challenge before snapping his neck. Trouble daughter's in the middle of his neighborhood, so his kid is secure for the time being until I decide to kill her. He undoubtedly has everyone in the neighborhood keeping an eye on her, but that's not an impossible issue.

MCCARTHY

So son, set the home on fire and give me a call when you're done so we can have everything cleaned up. As soon as you've burned the bitch, kill Kane immediately.

MICHAEL KILLER

Okay pops you got it.

CUT TO:

INT: PRVT MCCARTHY HOUSE- NIGHT

Kane emerges from the shadows with a revolver as McCarthy hangs up. McCarthy is informed by Kane that you and your kid decided to go on this insane murdering rampage to get revenge . Your son became a serial killer.

KANE
(Furious)

I trusted you. To me, you were like a dad. Your foolish ass son stole the bullet from the murder scene, and now you want

to blame my wife for performing her job. When you already knew who the murderer was, you made me go to all of this trouble to find him. I didn't realize it was your son until I started doing my homework, as you can see. When you showed me images of your family, the two boys appeared to be twins, but I didn't realize it at the time.

After serving in the military in Europe for two years, you left on a vacation on November 25, 14 years ago, and returned as a different person. Now that I understand why, I really apologize for your loss; nevertheless, I appreciate the fact that you've involved my family. You appeared to have seen a ghost when you came to see me and Kristine that day 5 years ago, and now I know why—she was the one defending the police officers who killed your son in court. Wow! This is absurd. This whole thing is crazy! You want to kill my wife and children after I save your life.

MCCARTHY

What do you mean? Your family is still going to die. I don't have a reason to live anymore.

KANE

Oh you don't? Well what about, Sean and Trinity? What you thought I didn't know you had 2 other kids in Europe. hahahah

MCCARTHY

You'll be dead before the night is over.

KANE

Oh really? Is that what you think?

Before we each returned to our respective homes five years ago, we were eating supper in Turkey. While using the toilet, you left your phone on the table, then you received a text message saying that my wife Kristine is investigating. I replaced your SIM card with a random one in place of yours.

MCCARTHY

Then you gave me a story about, phones losing data in that area and I believed you. Damn your very clever. So all this time you knew our plan.

KANE

Not only was I aware. I had prepared for it. Do you know who is to blame for your house not being sold by anybody as you can see that the house your son lives in is the same one he purchased? Yep, it's me, yours truly. When he got the opportunity, I knew He would buy it.

Kane shoots McCarthy in both legs with a pistol with a silencer on it, making it impossible for him to run.

KANE

I hooked up cameras, and put high tech doors on the home and made it so i can control them, with my phone i can lock up the whole house. so the room my wife and son is in is all secure and there's no way in. Your son will be there soon. He will grab the gas can's and realize that they are filled with water. Once he enter the house my phone will get a notification and I'll lock the house up then I'm going over there to have a hand to hand combat. I am going to kill him. With the knife he killed all them officer and gang member, i am going to slice his neck open. Then him and his twin will be back together again.

MCCARTHY

You ass..

McCarthy gets shot in the head by Kane. He received a phone notice informing him that Michael had come home. When Michael finds he doesn't smell any gas after grabbing the gas can and starting to spill the liquid material all over the home. The liquid is only water, according to his smell and taste. He throws the can because he is angry. Each door then locks. Michael can hear the windows and doors clicking. He tosses a chair against the glass window but doesn't break, while trying to open the front door, but it doesn't shatter. He makes an attempt to enter the room where Kristine and her kid are. Kane then uses his phone's speaker to speak to Michael from wherever in the house.

KANE

Michael how does it feel to be played and trapped. You really thought you can outsmart me. I bet this wasn't in your plans.

MICHAEL KILLER

Come out and show your face. You better shoot me if you dare to have a chance against me.

KANE

Gun, for you. nota chance I am going to beat your ass for kidnapping my wife and child then I am going to slice your throat.

By the way, your dad went to see your brother before you

MICHAEL KILLER

(Angry full of rage)

What! You better not put a finger on him or I'm going to kill you.

KANE

OOps too late for that, Your dad is permantly out of commision. He has a bullet in his head but I'm going to eave it there for evidence. Something that you should had done, and your brother killer would have been arrested but your so clever and stupid you took the only evidence that could have put your brother killer in prison.

MICHAEL KILLER

Shut the hell Up! Come out.

Kane slowly walks down the stairs to meet Michael. They start to fight; they both have special trained abilities. Kane is being defeated by Michael. Kane is being beaten. Michael tell's Kane he should have shot him, Kane is thrown, bloodied and spewing blood over a glass table. Michael is kicking him as he crawls. pulls the pistol from Kane's holster, Then kicks him while pointing a pistol at him. He is informed that his brother is the next to die.

When Kane becomes enraged, he forces Michael to drop the pistol. then rises. Michael gets beat up. Punches him to demonstrate his impressive abilities. Michael is then kicked through the television, leaving him wounded. H e seizes the knife that Michael used to kill the victim, slices off Michael's head, and he bleeds out.

Then Kane opens the doors so that his kid and wife may leave. He gives them hugs and kisses. Kane takes McCarthy's SIM card, a that has McCarthy and his son plans to assassinate police officers and gang members. He then inserts it into the computer to transfer files to the US president. He, his wife, and their kid go outside to their car, which is a mile away. Kane pulls a button, and as they drive away, they see a massive fire and smoke behind them from blowing up the house.

CUT TO:

INT. KANE NEW HOME IN EUROPE- DAY

While Kane watches the news, where they show and describe the car explosion of Chief, Kristine's father, Kane Jr. is playing outside with his mother.

KANE

"My life was in ruins and now I have redemption."

Michael switches off the television, goes outside to play with his family while grinning and having a nice time.
